The finca has a wood-fired sauna, a swimming pool with Jacuzzi, a barbecue area with bar and beer barrel tower as well as a large terrace.

It is the ideal place to get away from it all and immerse yourself in the relaxed Mediterranean island life. Pure enjoyment all year round.

The entrance hall of the charming house leads directly into the living-dining room and a large kitchen. The kitchen is equipped with an electric hob, fridge, oven, microwave, dishwasher and all the necessary kitchen utensils. The spacious living area has direct access to the terrace overlooking the pool. On the first floor there are 2 double bedrooms with en-suite bathrooms, one of which is handicapped accessible.

On the second floor there are 3 further double bedrooms with en-suite bathrooms and whirlpool baths. Two of the bedrooms have private terraces.

The house is furnished in a modern Mallorcan style with antique elements that have been restored by the owner.

All the furniture is handmade and was custom-made by local craftsmen using Mallorcan materials.

The house has underfloor heating in all rooms, air conditioning with aerothermal system. Through "Airzone" you can control the temperature of your home remotely.

This fully equipped house leaves nothing to be desired and your stay will be a particularly beautiful experience in the middle of the idyll of Mallorca and surrounded by the most beautiful bays of the southeast. The finca is ideal for couples or families who want to get away from it all and live in the heart of Mallorca.
