description:

This bright, modern villa, built in 1993, stands on a plot of 1.450 sqm and has a living area of 423 sqm spread over 2 levels. It was built by the prominent architect Pedro Rabassa Sansaloni who was well-known to be far ahead of his time.

Its modern, timeless design allows the entry of ample natural light, and its open design has lost none of its charm even over the last 30 years. Almost every room offers spectacular views over the whole bay of Palma as far as the Tramuntana mountains. It is entered via the ground-floor reception area which connects openly and seamlessly with the living/dining/kitchen areas. Due to the diverse glass elements all rooms are very bright and friendly. On this level is also a utility room, a bedroom and the double garage, and a wintergarden/covered terrace with access to the pool, a sun terrace and the compact garden. The latter mainly consists of Mediterranean plants and is low-maintenance.

On the upper level of the villa there are 3 further bedrooms, each with en-suite bathroom, the main bedroom also equipped with a dressing room and an office.

This exceptional property even has a touristic rental licence, and also offers the opportunity to expand its living space as this possibility was initially planned.

Below the house is access to the sea which is reached via a wooden walkway. Palma's airport and the centre of Palma are only 10-15 minutes drive away.

With only a minimum amount of work this lovely villa can be brought up to the most modern status, captivating with its modern, timeless design.







